## **SPECIFIC INSURANCE REQUIREMENTS**

**All coverages must be placed with a Best's "A" rated insurance carrier. Any rating less will not be accepted.**

### **1. Commercial Auto Liability**

Limits \$1,000,000.00 combined single limits per occurrence, or greater.

**Note:** An owner-operator, one who personally operates his own tractor or truck and has no Operating Authority. Coverages stating either "Any Auto" or "Scheduled Auto, Hired Autos and Non-owned". All others must have coverage stating "Any Auto".

### **2. Trailer Interchange, All Risk (AKA: All Other Perils) – Including theft**

Limits \$40,000.00. This coverage is used to provide legal liability protection for physical damage to trailers not owned, but in your possession.

### **3. Motor Truck Cargo, Legal Form – Special Perils Coverage (AKA: i.e., All Risk)**

Limits \$100,000.00 against your legal liability for loss or damage to merchandise of other while it is loaded for shipment and in transit in or on a covered vehicle.

**Note:** The policy shall be endorsed to expand the protection provided under the policy to include Broadened Definition of In-transit, refrigeration breakdown (including Product Spoilage Coverage) and loading and unloading. State any warranties that spell out conditions for coverage to stay in effect (i.e., locked vehicle).

### **4. Workers Compensation and Employer's Liability**

Limit \$1,000,000.00. If there are no employees, please provide a statement of such. (Addendum C)

"endeavor to ... but failure to ... (end of sentence)" wording must be removed from statement, and endorsement to policy. (Form CG-0212 or carrier's equivalent endorsement.)
